(1) The reporting person was originally granted 100,000 Restricted Stock Units on September 17, 2009 which vested 100% on September 17, 2014. The Board concluded to change the reporting person's compensation effective September 25, 2009 and cancelled the 100,000 Restricted Stock Units. The reporting person shall receive \$100,000 per year which he can choose to be paid either in Company stock or in cash. For the first year, the reporting person will receive 16,667 shares of the Company's common stock, based on a share price of \$6.
