- (1) Stock Incentive Plan and are subject to the terms and conditions of the Plan and the applicable award agreement entered into between the Company and the holder. These shares are subject to the following vesting requirements: 1/8 of the grant will vest on June 18, 2012 and thereafter every six months over the remaining 4 year period until all such RSUs are vested on 12/18/14.

These shares are held for the account of the reporting persons spouse and the reporting person may be deemed to be the indirect beneficial owner of these shares. The reporting person disclaims beneficial ownership of common stock held in the account except to the extent of

- (2) his pecuniary interest therein.
