- (1) These restricted stock units convert into common stock on a one-for-one basis.
- (2) Shares withheld to cover tax withholding obligations upon the vesting of restricted stock units.

These restricted stock units, which convert into common stock on a one-to-one basis, were granted under the Company's 2013 Omnibus Incentive Plan in a transaction exempt under Rule 16b-3 and, except as otherwise provided in the award notice, vest one-third on each of the first three anniversaries of the grant date, subject to Mr. Sheller's continuous employment with the Company.

- (4) Incentive Plan in a transaction exempt under Rule 16b-3 and, except as otherwise provided in the award notice, vests one-third on each of the first three anniversaries of the grant date, subject to Mr. Sheller's continuous employment with the Company. The number of shares underlying the option cannot be determined at this time, but will be based on \$302,400 divided by the Black-Scholes valuation of the option on the grant date. Once the number is determined, Mr. Sheller will file an amendment to this report.
- (5) This option was granted under the Company's 2013 Omnibus Incentive Plan in a transaction exempt under Rule 16b-3 and, except as otherwise provided in the award notice, vests one-third on each of the first three anniversaries of the grant date, subject to Mr. Sheller's continuous employment with the Company. The number of shares underlying the option cannot be determined at this time, but will be based on \$302,400 divided by the Black-Scholes valuation of the option on the grant date. Once the number is determined, Mr. Sheller will file an amendment to this report.
