This Amendment No. 4 to Schedule 13D (this <u>"Amendment No. 4</u>") is being filed with respect to the Common Stock, par value \$0.00001 per share (the <u>"Common Stock</u>"), of Enphase Energy, Inc., a Delaware corporation (th<u>e</u> "Issuer"), to amend the Schedule 13D filed on April 9, 2012 (as amended by Amendment No. 1 thereto filed on August 21, 2014, Amendment No. 2 thereto filed on September 30, 2016 and Amendment No. 3 thereto filed on March 20, 2017, the <u>"Schedule 13D</u>"). Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Schedule 13D.

This Amendment No. 4 is being filed on behalf of Third Point LLC, a Delaware limited liability company (the <u>"Management Company</u>"), Daniel S. Loeb, an individua<u>l ("Mr. Loeb</u>"). and Third Point Advisors II L.L.C., a Delaware limited liability company (<u>"Third Point Advisor</u>s", and together with the Management Company and Mr. Loeb, the <u>"Reporting Person</u>s").

The Management Company is the investment manager or adviser to a variety of hedge funds and managed accounts (such funds and accounts, collectively, the <u>"Funds</u>"). Third Point Advisors serves as the general partner of certain of the Funds. The Management Company and Mr. Loeb may be deemed to have beneficial ownership over shares of Common Stock directly beneficially owned by the Funds, by virtue of the authority granted to them by the Funds to vote and to dispose of the securities held by the Funds, including the Common Stock.

This Amendment is being filed to report that none of the Reporting Persons beneficially own more than 5% of the Common Stock.

This Amendment No. 4 is being filed to amend Item 5 of the Schedule 13D as follows:

Item 5. Interest in Securities of the Issuer.

Items 5(a), (b) and (c) of the Schedule 13D are amended to reflect the following:

(a) As of the date of this Amendment No. 4, none of the Reporting Persons beneficially own any shares of Common Stock.
