This Amendment No. 1 to Schedule 13G (as amended, the “Schedule 13G”) is being filed jointly by TPG Group Holdings (SBS) Advisors, Inc., a Delaware corporation (“Group Advisors”), David Bonderman and James G. Coulter (each, a “Reporting Person” and, together, the “Reporting Persons”), pursuant to an Agreement of Joint Filing incorporated by reference herein in accordance with Rule 13d-1(k)(1) under the Act.

Group Advisors is the general partner of TPG Group Holdings (SBS), L.P., a Delaware limited partnership, which is the sole member of TPG Holdings I-A, LLC, a Delaware limited liability company, which is the general partner of TPG Holdings I, L.P., a Delaware limited partnership, which is the sole member of each of TPG Biotechnology GenPar Advisors, LLC, a Delaware limited liability company (“TPG Biotech GenPar Advisors”), and TPG Ventures GenPar Advisors, LLC, a Delaware limited liability company (“TPG Ventures GenPar Advisors”). TPG Biotech GenPar Advisors is the general partner of TPG Biotechnology GenPar, L.P., a Delaware limited partnership, which is the general partner of TPG Biotechnology Partners, L.P., a Delaware limited partnership (“TPG Biotech”), which directly held shares of Common Stock of the Issuer (the “TPG Biotech Shares”). TPG Ventures GenPar Advisors is the general partner of TPG Ventures GenPar, L.P., a Delaware limited partnership, which is the general partner of TPG Ventures, L.P., a Delaware limited partnership (“TPG Ventures” and, together with TPG Biotech, the “TPG Funds”), which directly held shares of Common Stock of the Issuer (the “TPG Ventures Shares” and, together with the TPG Biotech Shares, the “Shares”). Because of Group Advisors’ relationship to the TPG Funds, Group Advisors may have been deemed to have beneficially owned the Shares.

David Bonderman and James G. Coulter are officers and sole shareholders of Group Advisors, and may therefore have been deemed to have beneficially owned the Shares. Messrs. Bonderman and Coulter disclaim beneficial ownership of the Shares except to the extent of their pecuniary interest therein.
