(a) Amount beneficially owned: Mr. Edelman beneficially owns: 4,509,185 shares (comprised of (i) 1,141,185 shares and notes convertible into 3,046,875 shares held by Perceptive Life Sciences Master Fund Ltd. ("Master Fund"), a Cayman Islands company of which the investment manager is Perceptive Advisors LLC, a Delaware limited liability company of which Mr. Edelman is the managing member, (ii) notes convertible into 300,480 shares held personally by Mr. Edelman and (iii) 40,672 shares held in an account of First New York Trading, LLC of which Mr. Edelman has voting and dispositive power.

(b) Percent of class: The beneficial ownership of 5.58% is based on the sum of (i) 77,508,767 shares issued and outstanding as of April 30, 2008 as reported on the Issuer's 10-Q as filed with the SEC on May 2, 2008, (ii) notes convertible into 3,046,875 shares held by the Master Fund and (iii) notes convertible into 300,480 shares held personally by Mr. Edelman.
