Elbit Systems Awarded a \$240 Million Contract to Provide an Array of Defense Electronic Systems to a Country in Africa

Haifa, Israel, September 26, 2017 – Elbit Systems Ltd. (NASDAQ: ESLT and TASE: ESLT) ("Elbit Systems") announced today that it was awarded a contract, in an amount of \$240 million, to provide a wide array of defense electronic systems to a country in Africa.

The contract, which will be performed over a two-year period, is comprised of Directed Infra-red Counter Measure (DIRCM) systems to protect aircraft from shoulder fired missiles (Man Portable Air Defense Systems -MANPADS), based on passive IR (Infrared) systems, and includes Missile Warning Systems (MWS), radio and communication systems, land systems, mini-UAS systems and helicopters upgrade.

Bezhael (Butzi) Machlis, Elbit Systems President and CEO, said: "We are proud to have won this contract, allowing us to provide our customer with a variety of systems and capabilities from different fields, a growing trend we have witnessed lately in many countries.
