As of the date hereof, (i) BVF may be deemed to own 2,507,198 shares of Common Stock, including 31,200 shares of Common Stock purchasable upon the exercise of the Warrants held by it, (ii) BVF2 may be deemed to own 1,736,283 shares of Common Stock, including 21,500 shares of Common Stock purchasable upon the exercise of the Warrants held by it, (iii) BVLLC may be deemed to own 6,373,919 shares of Common Stock, including 83,000 shares of Common Stock purchasable upon the exercise of the Warrants held by it, and (iv) ILL10 may be deemed to own 683,086 shares of Common Stock, including 9,300 shares of Common Stock purchasable upon the exercise of the Warrants held by it.

Partners, as the general partner of BVF and BVF2, the manager of BVLLC and the investment adviser of ILL10, may be deemed to beneficially own the 11,300,486 shares of Common Stock, including 145,000 shares of Common Stock purchasable upon the exercise of the Warrants, beneficially owned in the aggregate by BVF, BVF2, BVLLC and ILL10.
