The additional shares of restricted stock will vest as follows: 242 shares in even increments over 3 years beginning January 2, 2016, 95 shares in even increments over 4 years beginning January 2, 2016, 154 shares in even increments over 5 years beginning August 25, 2015 and 297 shares in even increments over 5 years beginning January 2, 2016.
