("Blum GP II"), the general partner of Strategic II. Blum GP II disclaims beneficial ownership of these shares, except to the extent of any pecuniary interest therein.
- (9) These shares are owned directly by Blum Strategic Partners II GmbH & Co. KG ("Strategic II KG").
