





ITEM 1.01 ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT

Credit Agreement Amendment

On March 31, 2011, Hub Group, Inc. entered into an amendment to its Credit Agreement with Bank of Montreal and Harris N.A., which increased its maximum unsecured borrowing capacity under the Credit Agreement from \$10 million to \$50 million and extended the term of the Credit Agreement another year until March 3, 2014.

The foregoing summary is qualified in its entirety by reference to the amendment to the Credit Agreement, which is attached hereto as Exhibit 10.1.

Purchase Agreement

On April 1, 2011, Hub Group entered into a material definitive agreement pursuant to which it acquired all of the capital stock of Exel Transportation Services, Inc. ("ETS"). The purchase price for the ETS stock was \$83 million before post closing adjustments, which Hub Group paid with cash on hand. ETS is now a wholly-owned subsidiary of Hub Group, operating independently as Mode Transportation, LLC. The foregoing summary is qualified in its entirety by reference to the Stock Purchase Agreement, which is attached hereto as Exhibit 10.2.
