CELLCOM ISRAEL ANNOUNCES PURPORTED CLASS ACTION  
FILED AGAINST THE COMPANY

Netanya, Israel – December 9, 2010 – Cellcom Israel Ltd. (NYSE: CEL) (TASE: CEL) (hereinafter: the "Company"), announced today that following its previous report dated December 2, 2010 regarding a major network malfunction and December 7, 2010 regarding a purported class action lawsuit filed against the Company in that regard, another purported class action lawsuit was filed against the Company in the District Court of Beer Sheva, by two plaintiffs alleging to be subscribers of the Company, claiming compensation for monetary damages and mental anguish, in connection with allegations that the Company misled its subscribers and unlawfully and in violation of its license and its agreement with its subscribers, failed to provide service to its subscribers during the network malfunction.

The total amount claimed if the lawsuit is certified as a class action was estimated by the plaintiffs to be NIS 1.3 billion.

At this preliminary stage, the Company is unable to assess the lawsuit's chances of success.
