Talking Points for use with Aetna Foundation Grantees and Partners

As you may have seen in the news, CVS Health, the largest pharmacy health care provider in the U.S., has agreed to acquire Aetna. This has no immediate effect on any Aetna Foundation grant programs.

Aetna is very excited about this combination. We will combine Aetna's industry leading health care benefits and services with CVS Health's 9,700 retail locations, 1,100 clinics and integrated pharmacy capabilities to become the trusted front door to health care.

Together we plan to build an entirely new health care concept that will deliver a better experience, reduce costs and improve access to trusted health care experts in communities across the country.

The combined vision ties directly to the Aetna Foundation's work to improve the health of individuals in local communities and large populations alike.

The coming together of the two companies will not impact the Aetna Foundation leadership, or its commitment to existing partners, program focus or relationships in the immediate and foreseeable future.

- We will continue funding and supporting all current grants and programs for the length of our commitments.

Aetna and CVS Health will continue to operate in all respects as two separate companies until the transaction closes, which we expect to happen in the second half of 2018.

We value and appreciate the relationship we share and we will keep you informed of any developments as the closing approaches and certainly provide relevant updates as needed, post-closing.
