Today, CVS Health and Aetna announced that they have entered into an agreement under which CVS Health will acquire Aetna.

Aetna's industry-leading health care benefits and services, combined with CVS Health's 9,700 retail locations, 1,100 clinics and integrated pharmacy capabilities, will create the trusted front door to health care. Together, we plan to build an entirely new health care solution that will deliver a better experience, reduce costs and improve access to trusted health care experts in communities across the country.

CVS Health and Aetna are committed to utilizing CVS Health's retail locations as community health hubs for Aetna members and other consumers . These hubs will provide a new health care solution dedicated to improving consumer well-being and answering questions about health, prescription drugs and health care benefits.

Today's announcement is just the first step in a lengthy process to bring the two companies together. We expect the transaction to close in the second half of 2018 after all regulatory and shareholder approvals.

Until then, we will continue to operate in all respects as two independent companies. Even after the transaction closes, it will take time for the companies to completely integrate and for change to occur.
