HRC was the record owner of 1,508,600 shares as of December 31, 2001. HRAM was the record owner of 194,000 shares as of December 31, 2001. (The shares held of record by HRC and HRAM are referred to collectively herein as the "Record Shares.") By virtue of their relationship as affiliated limited liability companies with the same individual as President, each of HRC and HRAM may be deemed to beneficially own all of the Record Shares. Hence, each of HRC and HRAM may be deemed to beneficially own 1,702,600 shares as of December 31, 2001.
