The Series R Notes will be issued pursuant to the Indenture dated as of October 1, 1991 (the Senior Note Indenture) between the Company and Citibank, N.A., as senior note trustee, and the Officers Certificate and Company Order dated April 25, 2008, pursuant to Sections 201, 301 and 303 of the Senior Note Indenture. The Series S Notes will be issued pursuant to the Indenture dated as of October 1, 1991, as amended by a First Supplemental Indenture dated as of April 1, 1993 (as so amended, the Subordinated Note Indenture) between the Company and Citibank, NA., as subordinated note trustee, and the Officers Certificate and Company Order dated April 25, 2008, pursuant to Sections 201, 301 and 303 of the Subordinated Note Indenture.
